February 2025



# 1. The Event

The 33<sup>rd</sup> SEA Games (SEAG) will be held from 9 to 20 December 2025 in Bangkok, Thailand.

# 2. Selection Panel

- 2.1 Singapore Bowling Federation (SBF)'s National Coaching Team will evaluate and recommend the bowlers to Selection Sub-Committee for approval for nomination to SNOC to represent Singapore at the SEAG.

# 3. Appeals Process

- 3.2 In the event where a bowler does not agree with the results of the team selection, the bowler must write in to the Appeals Sub-Committee **strictly** within seven (7) days after official team announcement is made/informed to the players via email. # 4. General Eligibility

- 4.1 To be eligible for nomination, each athlete must:
  - (a) Be a citizen of the Republic of Singapore (Athletes must be Singapore Citizens and should not be holding dual citizenship if they are above 22 years old at the time of nomination.)
  - (b) Agree and sign the SBF's Code of Conduct/Bowler Agreement

# 5. Selection Criteria

Selection Criteria	Assessment Factors	Weightage
Present Form	Based on results of competitions listed in Annex A	25%
Technical Skills	Variation; Shot repetition; Shot consistency; Matching up to oiling patterns	25%
Ability to Handle Pressure	Based on performances during competitions listed in Annex A & past majors	15%
Competition & Training Attitude	Team Events performances; Day to day attitude during training; Dedication, Team Spirit; Mental toughness; Commitment	20%
Strike & Spare Percentage	Based on results of competitions listed in Annex A	15%

# 6. SBF's Final Selection

- 6.1 Athletes must fulfil the requirements in clause 3 and be selected based on the selection criteria stated in clause 4.
- 6.2 Athletes shall be required to be certified medically fit to compete at the SEAG by qualified SSI personnel prior to nomination to the SNOC and shall remain medically fit to compete to be eligible to compete in the SEAG.



6.3 If a nominated athlete fails to fulfil the requirements stated in clause 3 and/or because of injury/illness is unable to represent Singapore at the SEAG, the selection panel, at its discretion, reserves the sole right to replace the nominated athlete with another athlete. Replacement athletes must also fulfil the requirements in clause 3 and selection criteria in clause 4.

### 7. SNOC Selection Criteria

- 7.1 Athletes who have currently achieved at least 3rd placing e.g., time/distance/score/mark of the 2023 SEA Games. For team sports, they should currently be ranked 3rd among the SEA Games countries. Athletes/Teams who miss the qualifying standard marginally but show potential to equal or surpass it in time for the Games.
- 7.2 Pursuant to the Olympic Charter (By laws to Rules 27 and 28, paragraph 2.1), "Selection shall be based not only on the sports performance of an athlete, but also on his ability to serve as an example to the sporting youth of his country."
- 7.3 In addition to the above selection criteria, the following "qualities" of the athletes will be taken into consideration:
  - Attitude and behavior towards coaches, teammates, fellow athletes, officials, and sports administrators, whether in relation to sporting matters or otherwise.
  - General conduct and character which may affect the reputation, image, values or best interests of the athlete or the sport.
  - Past disciplinary record.
  - Current skill level and fitness; and character
  - Level of commitment and attendance.
  - Potential for future development.



- Ability to demonstrate team spirit and work well with teammates and officials; and
- Such other non-performance related qualities as the selectors may consider to be relevant.
